B. SPECIAL INSTRUCTIONS

CASE TYPE ASSIGNMENTS

- 1. All evictions cases shall be filed based upon the zip code of the premises subject to eviction.
- 2. All other county court civil types shall be filed based upon zip code of the plaintiff unless represented by counsel, in which case, the business address of counsel will be substituted.

- 3. All other county court civil cases filed with zip codes other than those specified in Section I of this order shall be assigned to the Central Courthouse, with the exception of zip code 33441, Deerfield Beach and zip code 33324, Fort Lauderdale; both zip codes shall be assigned to the South County Courthouse. This change in zip code assignment shall be effective Monday, March 3, 2025.
- 4. All county court civil cases filed absent a zip code shall be assigned to the Central Courthouse.
- 5. The Clerk of Court shall program its computer system to ensure all Central County Court Civil Divisions (RB, RE, RF, RJ, and RL) are assigned all categories of case type (small claims -00, evictions-01, standard civil-02, replevin-28, non-monetary actions-29 and replevin-30).
- 6. Animal abuse cases filed pursuant to Florida Statutes Section 828.073 shall be initially assigned by computer system and then reassigned by the Clerk's office to ensure equitable distribution of this case type across all appropriate divisions.
